A. CALL TO ORDER

District Manager Jason Pierman called the December 15, 2017, Regular Board Meeting of the Marsh Harbour Community Development District to order at 10:00 a.m. at the Marsh Harbour Community Clubhouse located at 1000 Marsh Harbor Drive, Riviera Beach, Florida 33404.

B. PROOF OF PUBLICATION

Proof of publication was presented that notice of the December 15, 2017, Regular Board Meeting had been published in *The Palm Beach Post* on October 2, 2017, as part of the District's Fiscal Year 2017/2018 Regular Meeting Schedule, as legally required.

C. ESTABLISH A QUORUM

Mr. Pierman determined that the attendance of Chairperson Charlene Little, Vice Chairman Nathan Gordon and Supervisors Judy Briggs, Heather Eccles and Allen Walker constituted a quorum and it was in order to proceed with the meeting.

Staff present were: District Manager Jason Pierman of Special District Services, Inc.; and District Counsel Ginger Wald of Billing, Cochran, Lyles, Mauro & Ramsey, P.A. (via conference call).

F. APPROVAL OF MINUTES

1. November 17, 2017, Regular Board Meeting

Mr. Pierman presented the minutes of the November 17, 2017, Regular Board Meeting. Without discussion, Ms. Briggs **moved** approval and Ms. Eccles seconded that the minutes of the November 15, 2017, Regular Board Meeting be approved, as presented. The **motion** carried 5 to 0.

Discussion ensued regarding security's reluctance to speak to residents concerning violations. Mr. Walker and Ms. Little agreed that speeding is an issue in the community, and suggested speed tables. Mr. Pierman noted that those would be an HOA issue, since the District does not own the roads. Mr. Gordon noted that the HOA has reduced the cost of parking stickers to \$10 to allow cars to enter more efficiently. Ms. Little suggested handing out flyers at the gate, and noted that there was no need to look at other security companies – the employees come from the same pool of people, and it's difficult to find good people to work there.

H. NEW BUSINESS

There were no New Business items to come before the Board.

I. ADMINISTRATIVE MATTERS

Mr. Pierman noted that he was working with FEMA to receive between 75% and 90% reimbursement for the debris cleanup that was done after Hurricane Irma. He cautioned, however, that the reimbursement can take several months.

There were no comments from the Board Members.

K. ADJOURNMENT

There being no further business to come before the Board, the Regular Board Meeting was adjourned at 10:23 a.m. on a **motion** made by Mr. Gordon, seconded by Mr. Walker and the **motion** carried 5 to 0.
